As you are already aware, the above company which employed you executed a general assignment for the benefit of creditors (the "Assignment") in favor of DSI Assignments, LLC, (the "Assignee") in accordance with the applicable provisions of Delaware law governing General Assignments for the Benefit of Creditors, 10 *Del. Any such claim is subject to any higher priority claims, including any secured creditor or claims of any agency of the federal government. Attached to this notice is an Affidavit of Employee Wage Claim form. This form must be completed and returned to the Assignee, at its Los Angeles, CA offices (the address is on the form) no later than **March 31, 2019** along with any documents supporting your claim. Former employees who fail to file their Affidavit of Claim by March 31, 2019 may not be entitled to share in any distribution on account of their priority wage claims arising out of the liquidation of the Companies' assets to the extent there is any value beyond the secured creditor's claims. The filing of an Affidavit of Claim does not guaranty that there will in fact be a recovery for unsecured creditors.
